1. Acceptance of Terms

By joining or participating in Air Oceanic, you agree to comply with:

- This Terms of Service document
- The Air Oceanic Constitution
- Community rules and policies
- Applicable network rules, including VATSIM policies

If you do not agree, you must discontinue use of Air Oceanic services.

2. Eligibility

Members must:

- Be at least 13 years old
 - Hold a valid VATSIM account
 - Speak and understand English
 - Maintain compliance with all applicable Air Oceanic policies

Air Oceanic reserves the right to deny or revoke membership at any time.

3. Member Responsibilities

Members agree to:

- Conduct themselves respectfully and professionally
- Follow SOPs, procedures, and operational requirements
- Use realistic flight simulation practices where required
- Maintain account security
- Provide accurate information when requested

Members may not:

- Harass or discriminate against others
 - Share malicious software or harmful content
 - Abuse systems or exploit bugs
 - Impersonate staff members
 - Use Air Oceanic services for unlawful purposes

4. Staff Authority

Authorised staff members may:

- Moderate community platforms
- Investigate misconduct
- Issue warnings or disciplinary actions
- Restrict or terminate access to services

All staff decisions may be reviewed internally at the discretion of the Executive Team.

5. Suspension & Termination

Membership may be suspended or terminated for:

- Violations of Air Oceanic policies
- Serious misconduct
- Abuse of systems or community members
- Failure to comply with operational requirements

Air Oceanic reserves the right to remove any member at its discretion.

6. Intellectual Property

All Air Oceanic branding, materials, documents, systems, and media remain the property of Air Oceanic unless otherwise stated.

Members may not reproduce or distribute official content without permission.

7. Third-Party Services

Use of these services is subject to their own policies and terms.

9. Amendments

Continued participation after updates constitutes acceptance of the revised terms.

10. Privacy & GDPR Compliance

Air Oceanic is committed to protecting member privacy and handling personal information responsibly.

By using Air Oceanic services, members **acknowledge** that limited personal information may be collected and processed for operational, administrative, training, moderation, and security purposes.

Air Oceanic aims to manage personal data in accordance with internationally recognised privacy and data protection principles, including standards consistent with the General Data Protection Regulation (GDPR) where applicable.

Members may request access to, correction of, or deletion of personal information held by Air Oceanic, subject to operational, legal, or security requirements.
